Hazard Communication for Asia, the Pacific Rim, and Latin America

Monday, March 16, 2015 Hilton San Francisco Financial District – San Francisco, California

Course Description

This course is designed to be an overview of the hazard communication regulations in Asia, the Pacific Rim, and Latin America. Emphasis will be placed on the Safety Data Sheet (SDS) and label requirements, but chemical control regulations and product registration requirements will also be briefly discussed.

The goal of this course is to provide an understanding of the HazCom requirements in these regions. This course will address a number of countries in each region, but concentrate on the primary US-export partners of China, Japan, Korea, Hong Kong, Singapore, Mexico, Taiwan, Australia, Brazil, and Thailand.

This is considered to be an advanced course. While there are no specific prerequisites for this course, it is recommended that participants possess a working knowledge of SDS and labels and an understanding of the principles of hazard communication and chemical control regulations, including a basic understanding of GHS.

Hazard communication professionals looking to broaden the scope of their expertise in international hazard communication regulations.
