# **Canadian Hazard Communication**

# **Course Description**

This half day course will be devoted to Canadian requirements and is intended to provide a description of all aspects of the Canadian WHMIS requirements for suppliers. Emphasis will be placed on those features that are different from the OSHA Hazard Communication Standard and on significant policy interpretations that are not contained in the relevant legislation or regulations. The course will cover the Canadian approach to health and safety regulations, how chemicals are classified, the special requirements for supplier labels and the preparation of MSDS, and obtaining trade secret protection for proprietary ingredients. The Canadian direction on implementing the upcoming GHS will also be discussed.

#### **Intended Audience**

The course will be focused on those companies who will continue to have trade with Canada until the GHS is fully implemented.
