## **Canadian Hazard Communication**

## **Course Description**

This course will provide an overview of the Canadian WHMIS 2022 requirements for suppliers. Participants are expected to have a good general understanding of the Globally Harmonized System for Classification and Labelling (GHS) and/or the U.S. Hazard Communication Standard 2024 (HCS 2024). The course will introduce the Canadian approach to the regulation of hazardous products, the WHMIS 2022 hazard classes and categories, SDS and supplier label requirements (including exemptions from these requirements), document retention requirements, and how to protect trade secrets (Confidential Business Information). Variances between the HCS 2024 and WHMIS 2022 implementations of the GHS will be highlighted, along with key updates due to the transition from WHMIS 2015 to WHMIS 2022.


Note: This course will not cover how to classify hazardous products
