Pesticides Hazard Communication

Sunday September 21, 2025 – PM Course Grand Hyatt Washington – Washington, DC

Course Description

This advanced topic course is intended as an introduction to pesticide hazard communication and an overview of the Environment Protection Agency Pesticide (EPA) regulations. Participants will be provided with a general understanding of why pesticides are regulated differently from other chemicals, the general hazard classification criteria for pesticides, and federal registration requirements for active ingredients and formulated products. Special emphasis will be given to the EPA Label Review Manual and the development of the pesticide label. Other topics include safety data sheets and differences from Globally Harmonized System. We will also cover biocides and other antimicrobials, and other current topics and issues.

This is an advanced topic course, and students should have a general understanding of toxicological principles and hazard communication

Intended Audience

Hazard communication professionals looking to strengthen their understanding of pesticide regulation, and to receive an overview of the Environment Protection Agency Pesticide (EPA) regulations with particular emphasis on labeling and other hazard communication.
