Advanced Topics in EHS: Risk Management and Communication

Monday, March 24, 2014 Charleston Marriott – Charleston, SC

Course Description

The Advanced Topics in EHS series of courses were designed to expand on topics that are introduced in the other SCHC courses. The topic of risk management and communication is introduced in the SCHC course *Hazard Determination and Risk Assessment*.

The objective of this course is to provide an in-depth examination of risk management and communication. For the purposes of this course, risk management is the process of selecting an appropriate response to the risks of chemicals and risk communication is the exchange of information on the risks of chemicals. Emphasis in this course is placed on balancing the technical information from a risk assessment with an understanding of the process and basis for a risk-based decision, the trust and integrity of those involved in the process, and the social, economic, and political concerns that impact a response to risk. The goal of this course is to provide participants with an understanding of the technical and interpersonal aspects of risk management and communication.

This is an advanced course. While there are no formal prerequisites for this course, it is strongly recommended that participants have a working knowledge of chemical hazards and risks and that they have either taken the SCHC course *Hazard Determination and Risk Assessment* or that they are comfortable with the principles presented in this course.
