Protecting Worker Health and Safety Executive Order

OSHA after the Inauguration of the 46th President



"Protecting Worker Health and Safety" Executive Order

On January 21st, 2021, President Biden signed an <u>executive order</u> to direct federal regulators to issue stronger safety guidance for workplaces operating during the pandemic. "Ensuring the health and safety of workers is a national priority and a moral imperative... [i]t is the policy of my Administration to protect the health and safety of workers from COVID-19".

In a recent article "Biden plans to ramp up OSHA" by Dave Johnson, the Editor-at-large outlined some of the expected changes to occur under the United States newly-sworn in President Biden. "This much is certain, based on public statements President-elect Joseph Biden made during his campaign, and since his election: The incoming president wants OSHA to issue an emergency temporary standard (ETS) for COVID-19 protections in the workplace, and he wants to double the number of federal OSHA inspectors."

COVID-19 will be an immediate concern for the Biden administration. There will be an emphasis of working with essential and non-essential workplaces to distribute the coronavirus vaccine and ensure continued worker safety. In Biden's <u>first days as</u> <u>President</u>, he has launched a "100 Days Masking Challenge" for all Americans, and signed an Executive Order requiring masks and social distancing rules be adhered to on federal properties. He also signed an Executive Order directing the OMB to develop recommendations to modernize regulatory review.

Johnson also writes "[t]he coming months, and perhaps years, will see tension between activists who want an aggressive "policing" OSHA and moderates who see benefits in a less adversarial, more collaborative approach that values outreach to all stakeholders, partnerships, and expert advisory boards and task forces. There is across-the-board agreement in one area: the agency needs to modernize.... [and] the agency needs to do much internal reconstruction". He outlines a long view of what internal renovations could achieve and the challenges of change, many of which have been speed bumps for OSHA throughout its 50-year history.

Model WHS Act Cross-Comparison Table

CA Prop 65: BPA and Proposed Rulemaking for Short-form Warnings

Model WHS Act Cross-Comparison Table

Safe Work Australia has implemented model Work Health and Safety (WHS) laws across much of Australia, Tasmania and the Commonwealth. There are minor variations in some jurisdictions, and Safe Work Australia has created a <u>cross-comparison table</u> that summarizes the similarities and differences between the model WHS Act and the WHS Acts of the jurisdictions that have adopted the model WHS Act. The table can be downloaded by using the link above.

Businesses that operate in more than one jurisdiction can use the comparison table to identify how the relevant WHS Acts differ in harmonized jurisdictions.

Most jurisdictions have implemented the model WHS Act. Western Australia has implemented the model WHS Act but it will not commence operation until regulations are finalized. The model WHS Act has not been implemented in Victoria.

The table will be updated periodically in consultation with jurisdictions, for example, to reflect any amendments to the model WHS Act or jurisdiction WHS Acts.

CA PROP 65: Bisphenol A (BPA) and Proposed Rulemaking for Short-form Warnings

California's Office of Environmental Health Hazard Assessment (OEHHA) released a <u>notice</u> regarding the reinstating the listing of Bisphenol A (BPA) as known to the State of California to cause reproductive toxicity. The notice is adding developmental endpoint to the existing reproductive toxicity (female endpoint) listing of bisphenol A (BPA) (CAS RN 80-05-7) on the Proposition 65 list of chemicals. Bisphenol A was originally added in May of 2015.

OEHHA also issued a <u>Notice of Proposed Rulemaking</u>: <u>Amendments to Article 6, Clear and Reasonable Warnings Short-</u><u>form Warnings</u>. The written public comment period for this notice is January 8, 2021 - March 8, 2021. Article 6 of Title 27 was adopted in 2016 and operative in 2018, and included provisions for shortform warnings, however there has been widespread use of the short -form warnings that do not adhere to the intents and purposes of Proposition 65. Various inquiries requesting clarification drove the OEHHA to amend Article 6. Several sections will be impacted.

ECHA Updates - Transfer of UK Registration and Candidate List Update

The European Chemicals Agency (ECHA) shared several updates:

<u>Transfer of UK registration to the EU to be completed by the end of</u> <u>March 2021</u> Some highlights:

Of the 2,140 REACH registrants in the UK, 80% started or completed their transfer of their registrations to the EU by the end of the transition period on December 31, 2020.

At least 2,900 UK registrations are now void and will be revoked as their transfer to the EU was not initiated by the end of 2020.

268 substances that were only registered with UK-based companies were not transferred and the corresponding registrations will be revoked.

<u>Candidate List updated for two chemicals that are toxic for</u> <u>reproduction.</u> Both substances are used in products, such as inks and toners, or produce plastics and rubber tires. Substances:

- 1. Bis(2-(2-methoxyethoxy)ethyl)ether
- Dioctyltin dilaurate, stannane, dioctyl-, bis(coco acyloxy) derivs., and any other stannane, dioctyl-, bis(fatty acyloxy) derivs. wherein C12 is the predominant carbon number of the fatty acyloxy moiety
