## TSCA: SNURs to Protect Workers Health

---

At the beginning of this month, the U.S. Environmental Protection Agency (EPA) [finalized amendments to its requirements for Significant New Use Rules \(SNURs\) to better protect the health of workers](#). SNURs can be used to require notice to EPA before chemical substances and mixtures are used in new ways that might create concerns. The latest amendments strengthen requirements that ensure workers have access to clear and consistent information about the risks they may face from toxic substances.

The Federal register docket for this is EPA-HQ-OPPT-2014-0650, and the EPA has identified potentially affected entities to include:

- Chemical Manufacturers (NAICS code 325).
- Petroleum and Coal Products (NAICS code 324).
- Merchant Wholesalers, Nondurable Goods (NAICS code 424).

The amendments addressed such topics as respirators, industrial hygiene and hierarchy of control over workers, PPE ([which is on the agenda at the upcoming Annual Meeting](#)), chemical substance and significant new use regulations, a rule that will require a hazard written communication program be developed and implemented for substance in each workplace in accordance with OSHA HCS 29 CFR 1910.1200, and much more. There were also amendment changes that brought additional consistency between OSHA requirements and GHS recommendations.

In response to comments received during the 2016 comment period, EPA determined that the amendments would apply only to SNURs issued after this rule is finalized, rather than affecting previously issued SNURs. All other amendments are being finalized as proposed.

### **LGAC Adopts Recommendations to Support Communities Nationwide**

The U.S. EPA's [Local Government Advisory Committee](#) (LGAC) [announced](#) that they have adopted recommendations on how the Agency can support local governments as they tackle PFAS contamination, advance environmental justice, and find ways to provide resources effectively. ### **CA Prop 65 Updates to Glyphosate Records**

---

California's Office of Environmental Health Hazard Assessment (OEHHA) [updated](#) the records and held a short public comment period earlier this month regarding exposures to glyphosate from consumer products. Among the added records were the EPA's report "Revised Glyphosate Issue Paper: Evaluation of Carcinogenic Potential" and the EPA report "Glyphosate: Report of the Cancer Assessment Review Committee. ### **Safe Work Australia: Respirable Crystalline Silica**

---

Safe Work Australia has [issued a call for public submissions](#) on how to best manage the respirable crystalline silica (silica dust) in Australian workplaces. Stakeholder comments and supporting evidence should be submitted online by August 15, 2022.

Simultaneously, there is a 6-week consultation period for persons conducting a business or undertaking (PCBUs), work health and safety professionals, government agencies, industry and peak bodies, employer and worker representatives, and other parties interested in managing the risks of respirable crystalline silica. ### **TSCA: Methylene Chloride & Trichloroethylene**

---

The U.S. EPA [released for public comment a draft revision to the unreasonable risk determination for methylene chloride](#) pursuant to the [Toxic Substances Control Act \(TSCA\)](#) section 6(b). The draft revised risk determination proposes to find that methylene chloride, as a whole chemical substance, presents an unreasonable risk of injury to human health under the conditions of use.

Methylene chloride, also called dichloromethane, is a volatile, colorless liquid with a chloroform-like odor. The chemical is often used as a solvent in vapor degreasing, metal cleaning, in the production of refrigerant chemicals, and as an ingredient in sealants and adhesive removers. Common consumer uses include adhesives, sealants, degreasers, cleaners and automobile products. EPA's methylene chloride risk evaluation identified adverse human health effects, including neurotoxicity and liver effects, from acute and chronic inhalation and dermal exposures to methylene chloride. EPA also identified cancer as one adverse human health effect of chronic inhalation and dermal exposures to methylene chloride. OSHA has long been tracking the injuries and fatalities associated with the [compound](#).

Additionally this month, the EPA has issued a [release for public comment a draft revision to the unreasonable risk determination for trichloroethylene](#) (TCE). TCE is a volatile organic compound used mostly in industrial and commercial processes. Consumer uses include cleaning and furniture care products, arts and crafts spray coatings, and automotive care products like brake cleaners.



EPA's TCE risk evaluation identified adverse human health effects for workers, occupational non-users, consumers, and bystanders who have inhalation or dermal exposures to TCE, including:

- Immunotoxicity;
- Reproductive and developmental effects;
- Cardiac and lung effects;
- Kidney and liver effects; and
- Cancer.
