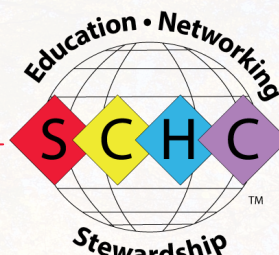

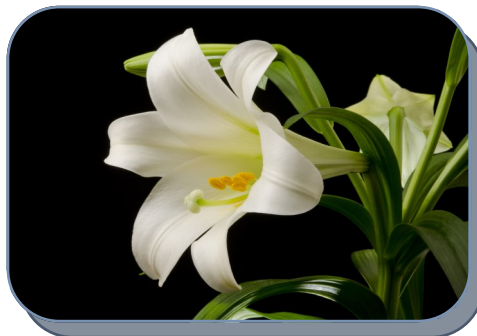

### **In Remembrance of Jennifer Silk**

---

Jennifer Silk, former Deputy Director of Standards and Guidance for the U.S. Occupational Safety and Health Administration (OSHA), passed away after a prolonged illness on October 22, 2019.



While at OSHA, Jennifer spearheaded the development of the US OSHA's Hazard Communication Standard, published November 25, 1983, sparking a revolution for the regulatory community. Darlene Susa-Anderson, former SCHC President, recalls her whereabouts when she first learned of the Standard and recounted her appreciation for Jennifer's patience in answering her questions as a young compliance professional.

SCHC Leaders who worked alongside Jennifer recall her as passionate and humble with a vision for the future of hazard communication, not just in the U.S., but internationally, as she chaired the international coordinating group that managed the development of the Globally Harmonized System of Classification and Labelling of Chemicals (GHS) and served as the U.S. expert to the United Nations Subcommittee of Experts on the GHS (UNSCE-GHS) for over a decade. Jennifer is widely respected in the international community and fondly regarded as the mother of Hazard Communication.

In September 1982, Jennifer was the first government member of the American Conference on Chemical Labelling (ACCL) and was instrumental in transitioning the organization to the Society for Chemical Hazard Communication (SCHC). Her dedication and contributions to the field of Hazard Communication were recognized with SCHC's Lifetime Achievement Award first in 1998 and again in 2003, the only person to receive the award two times.

After retiring from OSHA, Jennifer continued working as a consultant and training advisor to the United Nations Institute for Training and Research (UNITAR). She had a gift for explaining complex requirements in an easy to understand way and regularly shared her knowledge with SCHC Members through numerous meeting presentations and professional development offerings.

Jennifer Silk was instrumental in shaping not only our Society, but obviously the Standard and application of Hazard Communication. Her voice will live on through the regulations we work with and are protected by every day.

In honor of her work to pass legislation to ban puppy mills in Pennsylvania, SCHC has made a donation in Jennifer's memory to United Against Puppy Mills, a fully volunteer 501(c)3 non-profit organization in Lancaster County, Pennsylvania.

### Investigating Vaping Lung Injuries

#### EPA Proposes Changes to WPS and AEZ

### Investigating Vaping Lung Injuries

---

The use of electronic cigarettes or “vaping” was a hot topic in October when the CDC released a [statement](#) that said there are more than 1,600 lung injuries reported related to e-cigarette usage. The exact cause of the lung injuries are unknown and no single product has been singled out as harmful. The Canadian government issued a similar [statement](#) that they too would be researching vaping as there were similar injuries reported in Canada. They will also be investigating e-cigarettes as a potential threat of exposure to harmful chemicals for people who are non-smokers.



### EPA Proposes Changes to Agricultural Worker Protection Application Exclusion Zone (AEZ)

---

Last week, [EPA proposed updates](#) to the Agricultural Worker Protection Standard (WPS) regulation in regards to enforceability and exposure of pesticides to farmers, their families, farm workers, pesticide applicators, and others.



The changes primarily impact the Application Exclusion Zone requirements and entry restrictions for enclosed space production. The proposed changes should not impact off-farm bystanders who are protected by the existing “do not contact” requirements that prohibits use in a manner that would contact unprotected individuals. There is a 90-day period for [public comment](#).

### Beryllium Standards for Construction and Shipyards

---

OSHA has issued a final rule on the beryllium standards for construction and shipyards. Under the final rule, OSHA will not revoke all of the standards' ancillary provisions. The final rule also extends the compliance dates for the ancillary provisions to September 2020 to account for OSHA's new proposal to revise or remove those provisions, and maintains enforcement of the lower permissible exposure limits. OSHA will also soon issue a proposed rule to amend the beryllium standards for construction and shipyards by more appropriately tailoring the requirements of the standards to the exposures in these industries, more closely aligning the standards to the general industry standard where appropriate, and clarifying certain requirements with respect to materials containing only trace amounts of beryllium.

### California Proposition 65 Updates

---

California's Office of Environmental Health Hazard Assessment (OEHHA) released three notices in October including a notice of modifications to text regarding [Responsibility to Provide Consumer Product Exposure Warnings](#) for chemicals listed under Proposition 65. A second notice marks the start of a 45-day comment period regarding the [Hazard Identification Materials for Cannabis Smoke and THC](#). Public comment is sought regarding a [proposed rulemaking of no-significant risk](#) regarding PCBTF.

In September, [several chemicals were added](#) to the list of chemicals known to cause cancer under Proposition 65.

### Postponement of Compliance Deadline for Reporting to Poison Centres

---

The CARACAL (expert group on CLP) has agreed unanimously to the European Commission's proposed changes to Annex VIII to CLP. The Commission is now proceeding with adopting a delegated act, which will, among other things, **postpone the first compliance date** for harmonised reporting to poison centres, for mixtures intended for consumer use, from **1 January 2020 to 1 January 2021**.



Entry into force is expected later this year. Other compliance dates will not be affected. The Commission is also progressing with solving some of the concerns raised by stakeholders on the

workability of the notification requirements and another amendment to Annex VIII is expected in 2020. Read the draft delegated regulation and stakeholder feedback [here](#).

### What's this TSCA Section 12(b) thing I've heard about?

---

Certain chemicals, defined and listed by the EPA, require EPA notification when exporting. This "12(b) notification" refers to the Toxic Substances Control Act section of the legislation that determines the list and requirements. This notification is done in partnership with your Product Safety & Regulatory partners, ideally before the product is shipped out (while acknowledging you may have a very small window to notify post export).

Examples of exports that could trigger this notification requirement include shipping products such as long chain perfluoroalkyl carboxylates or perfluoroalkyl sulfonates. Can't wait to know more? The EPA is happy to help [here](#).

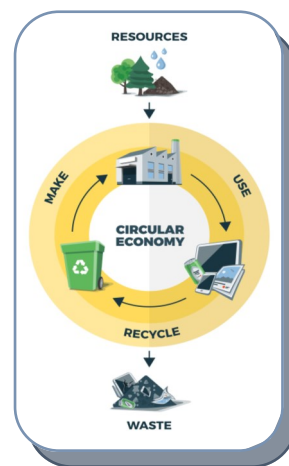

### ECHA SCIP Workshop

ECHA's Waste Framework Directive was conceived to address the adverse impacts of waste and improving efficient use of resources as part of the transition to a circular economy model. Revisions in 2018 tasked ECHA with developing a database with information about substances of very high concern (SVHCs) on the Candidate List. The database is called [SCIP](#), which stands for **S**ubstances of **C**oncern **I**n articles, as such or in complex objects (**P**roducts).

The ECHA will host a [SCIP database workshop](#) on November 12<sup>th</sup>, to discuss and disseminate information with stakeholders. Registration for the workshop is closed but results will likely be shared on [this page](#).

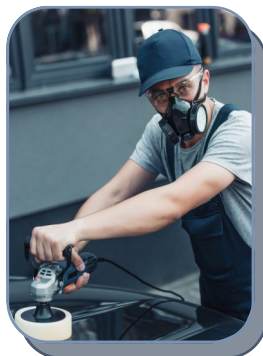

### OSHA Approves New Respirator Fit Testing Protocols

If you are not already aware, OSHA has issued a final rule that provides employers with two new fit testing protocols for ensuring that employees' respirators fit properly. The new protocols are the modified ambient aerosol condensation nuclei counter (CNC) quantitative fit testing protocol for full-facepiece and half-mask elastomeric respirators, and the modified ambient aerosol CNC quantitative fit testing protocol for filtering facepiece respirators. Both protocols are variations of the original OSHA-approved ambient aerosol CNC protocol, but have fewer test exercises, shorter exercise duration, and a more streamlined sampling sequence.
