Course Description and Objectives

This online course covers some of the practical elements of UK REACH aimed at exporters to the UK and will be part of a joint registration, working with UK importers (customers and distributors) or UK based Only Representatives.

The objective is to ensure that the non-UK exporter realises that there is a lot of the technical work that can be done by themselves and that the importer or Only Representative who is managing the registration does not have to do all the work. Even if relying on third-parties as legal registrants, it is important to appreciate what is and what is not needed in order to manage work-load and costs.

Although the UK and EU will maintain virtually parallel systems in terms of terminology and technical standards, there are issues with regard to responsibility in the supply chain, especially if supplying the UK and EU through hubs in the UK or EU.

Determining responsibility is important for issues such as registration of substances, provision of SDS and labelling of chemicals. Exploring options of supply line responsibility can improve efficiency and help decide if using customers or distributors is preferable over paying for professional third party service providers or vice-versa.
