Course Description

This course is designed to teach both the assessment of environmental toxicity data relating to transportation and the various ways transportation regulations worldwide address environmental hazard communication. Many Dangerous Goods transportation experts lack expertise in Environmentally Hazardous Substance classification data analysis. Many environmental toxicologists lack expertise in the various ways transportation regulations address environmentally hazardous substances, from multiple lists to criteria to various exceptions based on size, mode of transport, and geography. SCHC now addresses all those issues in one course **divided into two independent sessions**.

The information in this course can be obtained separately by taking both an SCHC course in environmental toxicology assessment, and, the SCHC transportation classification course.
